**DEFENDANTS' SECOND UNOPPOSED MOTION FOR
ENLARGEMENT OF TIME TO RESPOND TO THE
COMPLAINT FOR DECLARATORY AND INJUNCTIVE RELIEF**

Phil Bryant, in his official capacity as Governor of the State of Mississippi, and Andy Gipson, in his official capacity as Commissioner of the Mississippi Department of Agriculture and Commerce ("State Defendants"), file this Second Unopposed Motion for Enlargement of Time to Respond to the Complaint for Declaratory and Injunctive Relief ("Complaint") and in support, state:

1. This suit involves a challenge to a portion of Mississippi Code Annotated Section 75-35-15 (Labeling of receptacles or covering of meat or meat food products; labeling requirements generally; standard of identity or fill; false or misleading labels), amended by the Mississippi Legislature in the 2019 Regular Legislative Session (Senate Bill 2922), and took effect on July 1, 2019.
2. The State Defendants' responsive pleadings are presently due on August 13, 2019.
3. The parties are currently engaged in negotiations that may lead to a resolution of the case. Due to the time required for adoption of proposed regulations under Mississippi's Administrative Procedures Act, more than 30-days are required before a final resolution could be consummated. In light of these developments, the Defendants' request a 60-day extension to file responsive pleadings

to the Complaint, making the responses due no later than October 2, 2019. At the conclusion of the 60-day extension, the parties will notify the Court whether the case has been resolved or will proceed.

4. Undersigned counsel has conferred with counsel for Plaintiffs and there is no objection to this request for this enlargement of time.

WHEREFORE, PREMISES CONSIDERED, the State Defendants respectfully request that the Court grant their unopposed motion for enlargement of time allowing them up to and including October 2, 2019 in which to respond to the Complaint.
