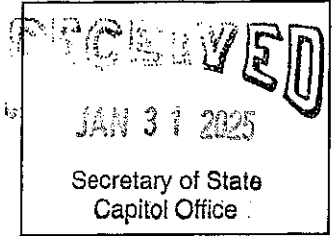

Political committees supporting or opposing municipal candidates or municipal ballot measures file with the municipal clerk's office.
